



The **TJF Memorial AIDS Walk** is named in honor of **Thomas J. Fahey Jr.**, the former Director of **BAMSI's HIV Team**. Tom dedicated his life to helping individuals and families at risk or infected by the HIV/AIDS virus.

Throughout his career, Tom served as an activist locally, nationally, and internationally, bringing into focus the numerous complications associated with HIV/AIDS. Tom was the co-founder of the Committee of Ten Thousand, a national organization advocating for individuals and families diagnosed with hemophilia, hepatitis, and HIV/AIDS. In recognition of his courage and lifelong work, Tom was honored posthumously receiving special recognition from Boston Mayor Menino, and Boston Public Health Commissioner John Auerbach. In 2003 BAMSI named the Annual **TJF Memorial AIDS Walk** in his honor. Tom died in September of 2002 while awaiting a liver transplant.

About the Walk

The TJF Memorial AIDS Walk raises community awareness and financial support for individuals and families living in the Brockton Area infected by HIV/AIDS.

One hundred percent of all money raised from the walk will provide emergency financial assistance to prevent homelessness and utility shut off's, and to cover out-of-pocket expenses associated with medical care.
